



# InterGen generates an efficient, reliable and auditable Security Model

## The Problem

As a privately held, global company with many sites across the world, InterGen found it difficult to create a manageable security model in which they could have full confidence.

InterGen has a complex structure, with multiple legal entities and a multi-layered organization. This resulted in a complicated security model with hundreds of roles – making it very difficult to manage and almost impossible to audit.

Although they are a privately-owned company, to ensure good governance they decided to voluntarily adopt security standards equivalent to those required for SOX compliance. This meant that they needed to create an auditable model that would enable them to conduct reliable semi-annual access and Segregation of Duties reviews to ensure that their security was up-to-date, effective and compliant.

## The Solution

The company selected Security Manager Pro (SMP) to build their new security model. SMP allowed them to define the security for their business processes as Components, which could then be attached to roles, as appropriate, to define the full range of responsibilities that each role could perform.

To restrict users’ access to appropriate data, they were also able to create data roles which specified the row security for the various locations and legal entities.

Each user could then be assigned the appropriate combination of functional and data roles that is appropriate for their job.

“With this methodology, we reduced the total number of roles to 60,” says Veer Ranganathan, Manager at InterGen. “The component approach made it much quicker and easier to create the new model, as well as to manage ongoing security changes.”
